### DISCOUNTS AND TUITION ASSISTANCE

- Payment in full: A 10% discount will be applied if tuition is paid in full by August 15, 2023.
- Tuition aid is available. All applications for tuition aid will be processed through FACTS, our tuition management system. A web portal for your application will be available by June 1<sup>st</sup>, 2023.

### BEFORE AND AFTER SCHOOL CARE

- Before and after school care of \$100 per week per student is due weekly on the Friday before the Monday of the following week. A deposit of \$200 will be due at the time of registration for Before and After School Care. This deposit will apply to the first 2 weeks of care. The third week will be billed to you and will be due the Friday before the third week begins.
- All day care for those days when school is not open, is available at the rate of \$30 per day per child, payable the Friday before the week care is needed. Parents must sign up at least 2 weeks prior to the date care is needed to allow for proper staffing. Students will be provided a morning snack, lunch and an afternoon snack.

## TERMS OF TUITION CONTRACT

1. Tuition may be paid in full or due each month based upon the contract plan approved by the school.
2. Should any account be more than sixty (60) days in arrears, the school has the right to suspend or dismiss the student(s) from attendance at the school. In case of default of payment, the account will be referred to a collection agency. I/We agree to pay balances due, collection costs, reasonable attorney fees, and legal interest incurred. The responsible party is liable for all tuition and fees incurred for the entire calendar month the student(s) voluntarily leave(s) or is suspended or dismissed.
3. Tuition for students enrolling after the start of the school year will be pro-rated and based upon the calendar month in which the student is enrolled.
4. I/We understand that all Tuition and fees MUST be current to be eligible for re-enrollment for the next calendar school year.
5. As a condition of St. John Paul II Classical Academy accepting the above-named child(ren), I agree to follow the rules and policies established by the Academy as set forth in the Parent Handbook, a receipt of which is hereby acknowledged.
6. I/We understand that as a condition of receiving tuition aid, I/We agree to provide at least 20 hours of volunteer time to St. John Paul II Classical Academy to be used in the furtherance of the Mission of St. John Paul II Classical Academy and as directed by the Academy's administration and board of directors.
7. I/We understand and will uphold the mission of St. John Paul II Classical Academy and will promote the environment of Catholic/Christian respect and love.
8. Continued enrollment will be based on a semester-by-semester review. The previous semester's tuition must be paid to continue in the next semester and successive school year.
9. I/We hereby approve and give our consent for the use of photos of my child(ren) in promotional materials and social media postings.
10. I/We hereby acknowledge that as the parent or legal guardian of the child(ren) being registered, I am responsible to keep all information authorizations pertaining to the child(ren) correct and current at all times.
11. I/We understand that my child(ren) may not be enrolled until all forms are completed, submitted, and approved.
12. I/We understand that initial enrollment is contingent upon successful completion of this Tuition Contract and payment of applicable fees.
13. **I/We understand that the Registration Fee is REFUNDABLE if not enrolling, and will apply to tuition and/or fees when student(s) is/are enrolled.**
14. I/We understand there will be a \$500 withdrawal fee assessed for any withdrawal prior to the last day of the 2023-2024 academic year. Refunds of any remaining tuition may take up to 90 days.

*I/We agree to abide by with the terms and conditions stated in this Tuition Contract. I/We have had the Tuition Contract explained and been provided the opportunity for questions. I/We understand this is a legal, binding, and enforceable contract.*

*I/We agree the tuition amount is accurate and will pay this amount. I/We am aware that additional discounts may be applied at a later date due to financial aid.
